Referring to our official letter №01/079 dated on 05 May 2011 concerning new policy of MTA, we hereby convey our policy concerning issuing Certificates of Endorsements for seafarers serving on ships flying Georgian Flag.

If Certificate of Endorsement is requested, the following documents should be submitted to the MTA in due course:

- 1. Application Form for Endorsement Attesting the Recognition of an Officer's Certificate of Competency (see attachment 1);
- 2. 2 (two) recent photos (3x4cm);
- 3. Physical examination form, taken within the last 12 month;
- 4. Copy of National Passport;
- 5. Copy of STCW 78/95 National Certificates;
- 6. Copy of the services acquired within the last 5 years;
- 7. Copy of National COC;
- 8. Copy of Seamen's Book;
- 9. Bill of Payment.

The Certificates of Endorsement are subject to fees under Georgian legislation, specifically, official fee for the issuing of Georgian Certificate of Endorsement is:

- USD 240 for Senior Officers;
- USD 173 for Operational Level Officers.

The official fees shall be paid before the Certificate of Endorsement is issued.
